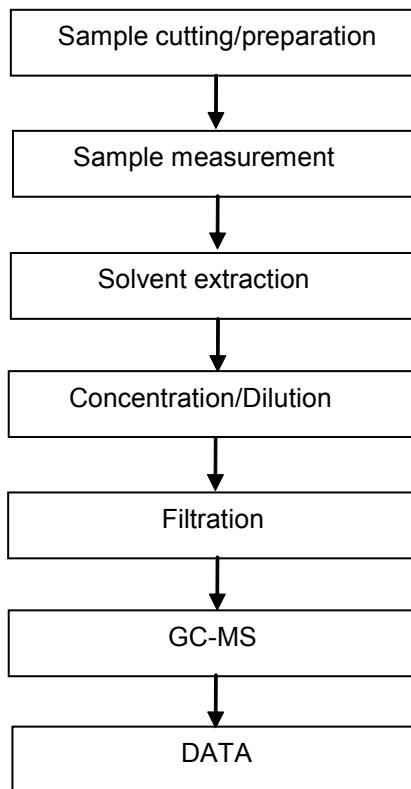

HBCDD Testing Flow Chart

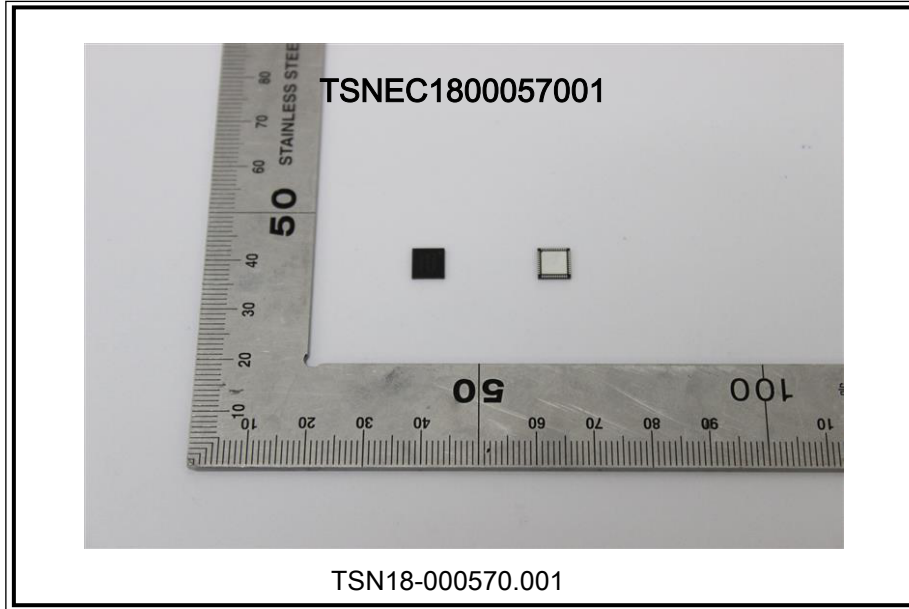
